5. Delegations:

a. David Oakes, Director of Economic Development for Niagara Region presented on the role of the Niagara Region Economic Development and Team Niagara (presentation attached).

6. BUSINESS

- a. Chair's Update:
 - Chair talked to the CAO, City does not have a structure for committee reports. Do not have a really good understanding if council reads and discussed the reports at council.

- CAO recognizes this is a problem and would like to help find some clarity and mandate
- Next steps Chair is meeting with senior staff at City Hall to get a mandate
- Committee has no authority to direct staff
- Councillors to mention reports at council meetings (even if they are not in attendance at EDAC meeting)

b. Staff Update:

- Housing Development
 - Westwood Estate have sold all 50 lots in Phase II
 - 18 housing permits issued by the end of May 2017 (the year 2016 there were 28)
 - Meadow Heights is selling Phase II with 73 lots (Development charges were paid in the 90's)
- Niagara Region has drafted a revised development charges by-law, Some of the changes are, 81% increase in a single/semi-detached, 462% increase in Apartments – 4 bedrooms and over
- The proposed changes will drop the Industrial charge rebate program from \$1,000,000 to \$600,000
- A report went to council supporting of the recommendations City of Welland's is making to the region. The City of Welland's report was comprehensive with data.
- Niagara Industrial Association is also recommending on dropping the annual rebate program and instead reducing the industrial development charge to \$0.00 per square foot.
- There was a public meeting on June 8th, going to Regional Corporate Services meeting on June 21st, and then going to regional council on Thursday, June 29th.
- Joint Chamber Business after 5 will be held at the Marina on Wednesday with delegations from Toronto Tianjin Business Association
- c. Organizational Review for the City of Port Colborne:
 - The organizational review (which was recommended by EDAC) is underway.
 - Chair has been interviewed has a stakeholder and has the chair of EDAC and recommended mores stakeholders be interviewed.
 - Some members of this committee will be called to be interviewed.
 - Organizational review is of the departments and operation of the city.
- d. Motions from May 4th EDAC Meeting on Committee Composition:
 - Council cannot have a fluid membership designating councillors exofficio has to be done by Council, cannot be selected by committee at start of each meeting.

- Confidentiality non starter all committee meetings are public meetings and advisory committee cannot go in-camera. General information can be given without names
- Physician recruitment goes in-camera to discuss physician agreement and contracts

 – will discuss with clerk
- Members miss three consecutive meets is already in the Policy & Procedure for committee meetings – table and bring back another time.

e. Staff Memorandum to City Clerk:

- Staff determined the most straightforward way for committee motions to get on Council agenda is through staff memorandum to Council.
- Memorandum was on agenda to show committee members how motions will be presented to Council – no vote required and future memorandums with motions will not return to committee, unless requested.
- Fred will discuss with Councillors Elliott and Mayne to ensure memorandums with committee motions are pulled for discussion at council meetings.


