	Maximum fee for a 6 month permit	\$1,040.00
	Example: 15 ha = \$104.00 + (\$21.00 x 14ha) = \$398.00	
	Note: Fees include inspection of control plans and site by City staff	
	Permit Extension Fee – fee per hectare	\$21.00
	Example: same 15 ha site = (\$21.00 x 15 ha) = \$315.00
